UPDATING YOUR CATALOG COPY AND USING THE GPAR SYSTEM

The <u>Graduate Catalog</u> is the official place for documenting UConn's graduate programs and their requirements. Programs should review their catalog language at least once a year to determine if any changes need to be made. This Timely Topics session will review the process and deadlines for making changes to the Graduate Catalog through the online <u>GPAR system</u>. It will also discuss how the GPAR system can be used for other program changes, including approvals of new programs and other program modification (e.g., changes in names, areas of concentrations, pathways, delivery modes, locations).
